## **Expanded eFiling Instructions**

WCG must electronically file all tax returns. Section 6011(e)(3) of the Internal Revenue Code requires specified tax return preparers to electronically file certain federal income tax returns if they prepare more than 100 tax returns annually.

## **Client Portal**

Log into your client portal and find the tax year folder with your tax returns. To the right is a snippet of Jason and Tina's client portal highlighting the Action Required PDF. You can access your client portal here-


