New Filing Deadlines

Income tax returns for individuals (1040) and corporations (1120) including a few others is extended to July 15, 2020. Q1 estimated tax payments for 2020 are also delayed (we suspect more penalty and interest forgiveness for underpayments... stay tuned). We also suspect that this will alter 401k and IRA contributions as well, but specific guidance has not been received. And! States might vary from this.
