### **July 15**

Individual tax returns (Form 1040) and those pesky corporate tax returns (Form 1120, no S) are due Wednesday, July 15. Some states are sooner (yes) and some states, like Colorado, smartly extended everyone to October 15. If you intend to have WCG prepare and file your tax returns, your **tax documents are due Wednesday, June 17** for a timely filing. Here is a link to our Getting Started tax page-
